





# AMEP Pathways to Employment Program (PEP) Course Information

The Pathways to Employment Program (PEP) will develop your employability and language skills and give you an introduction to the Australian work culture and how to effectively participate in the workplace.

## Courses offered in Term 2, 2024

#### Aged Care and Disability – Location: St George

This course will provide you with the skills required to assist people who may require support due to aging or disability. A work experience placement is included in this course. Participants in this course must meet the requirements below.

- Able to obtain a National Police Check
- Must have a current Flu vaccination
- Have completed the minimum of the 1st and 2nd doses plus the 1st booster of the COVID-19 vaccination

#### Early Childhood Education and Care - Location: Miller

This course also offers you a pathway to exploring further education for working in the Early Childhood Education and Care sector. A work experience placement is included in this course. Participants must be able to obtain a Working with Children's Check and have been vaccinated for a minimum of 2 doses of the COVID-19 vaccine.

#### Introduction to the Australian Workplace Culture – Location: St Leonards

This course will provide you with an opportunity to learn about the Australian workplace culture and values. It will also develop your workplace communication and job-seeking skills including resume and cover letter writing, interview skills and networking techniques. A work experience placement is included in this course.

#### **Business Administration – Location: Ultimo**

This course will provide you with the skills required for employment in general business operations. You will learn about Work Health and Safety, how to design and produce simple documents and use workplace technology. A work experience placement is included in this course.

10 weeks (full-time) Tuesday, 30 April to Friday, 5 July Week 1 to 8 Classroom based training Week 9 to 10 Work placement

#### **Study commitment**

20 Hours, 4 days per week

#### Childcare
