#### **1.0 ESTABLISHMENT AND PURPOSE**

- 1.1 The Woolfson Encouragement Award was established in 2017, by Liz Woolfson.
- 1.2 The Woolfson Encouragement Award is funded by Liz Woolfson and managed and administered by the Hunter TAFE Foundation.
- 1.3 The selection panel will be established to assess the Woolfson Encouragement Award nominations on behalf of Liz Woolfson, and will put forward a recipient to Liz Woolfson for endorsement.
- 1.4 One Woolfson Encouragement Award, to the value of \$500, will be awarded annually at the sole discretion of the selection panel.

#### 2.0 DEFINITIONS

- 2.1 **"Award recipient**" means successful nominee who accepts the Woolfson Encouragement Award, by completing and returning the offer and acceptance form in accordance with the process set out in clause 6.0 of these terms and conditions.
- 2.2 **"Eligible nominee"** means a nominee who meets the criteria for eligibility for the Woolfson Encouragement Award, as set out in clause 4.0 of these terms and conditions.
- 2.3 **"Nomination**" means a nomination for the Woolfson Encouragement Award, made by a nominator, in accordance with these terms and conditions.
- 2.4 **"Nomination form"** means the form that must be completed by the nominator, and is available at tafensw. edu.au/scholarships
- 2.5 **"Nomination process"** means the process set out in clause 3.0 of these terms and conditions as amended or varied by the Hunter TAFE Foundation from time to time, in its sole discretion.
- 2.6 **"Nominee"** means a student who has been nominated for the Woolfson Encouragement Award.
- 2.7 **"Offer and acceptance form"** means the form that must be completed by the successful nominee, and is to be issued by the Hunter TAFE Foundation.
- 2.8 **"Selection panel"** means a panel comprised of representatives from TAFE NSW, to assess all nominations and recommend an award recipient.
- 2.9 **"Successful nominee"** means an eligible nominee who is offered the Woolfson Encouragement Award by the Hunter TAFE Foundation, in accordance with the process set out in clause 5.0 of these terms and conditions
- 2.10 **"Woolfson Encouragement Award"** means an award to the value of \$500 is awarded by the Hunter TAFE Foundation in accordance with these terms and conditions.

#### **3.0 NOMINATION PROCESS**

- 3.1 A nominator and nominee must complete a nomination form and submit it to the Hunter TAFE Foundation by the required closing date.
- 3.2 The nominator and nominee must acknowledge and accept the Woolfson Encouragement Award terms and conditions by signing and dating the declaration on their nomination form.

#### 4.0 STUDENT ELIGIBILITY FOR THE WOOLFSON ENCOURAGMEENT AWARD

- 4.1 The Woolfson Encouragement Award may be awarded to an eligible nominee who has completed and lodged a nomination form and who, as determined by the selection panel as eligible (in its sole discretion), satisfies all of the following criteria:
  - 4.1.1 Is enrolled as either a part time or full time student at TAFE NSW Maitland, in one of the following courses as listed below in the same year as the award is offered:
    - BSB20120 Certificate II in Workplace Skills
    - BSB30120 Certificate III in Business (Administration)
    - BSB30120 Certificate III in Business (Medical Administration)
    - BSB40120 Certificate IV in Business Administration
  - 4.1.2 Must be a mature age student. For the purpose of this award, a mature age student has been defined as a student over the age of 30 years in the year that the award is offered.
  - 4.1.3 Must have an excellent attendance record.
  - 4.1.4 Must have demonstrated commitment to study and to transitioning into the workforce.
  - 4.1.5 Would benefit from the financial assistance and encouragement provide by the award.
- 4.2 Incomplete nomination forms will not be considered by the selection panel.
- 4.3 The Hunter TAFE Foundation is under no obligation to attempt to contact any nominator who incorrectly completes and/or submits a nomination form and will, at his or her discretion, contact a nominee on not more than two (2) occasions in an effort to obtain information which is missing, or has not been completed correctly. Should all required information not be provided, the nomination form will be withdrawn by the Hunter TAFE Foundation and notice sent to the nominator.
