Under the gentle guidance and continual encouragement of his dedicated teachers, he began to embrace with ever growing confidence his newfound abilities, passion for knowledges and desire for excellence. It was, indeed, a beautiful process to witness. His further studies transforming a dream into a reality, enabling a legacy that continues in his name today. None of us can ever really know where our futures will lead, however Henry's most definitely began at TAFE. The award is valued at \$1,000 and awarded each semester to outstanding student who overcome the challenges and difficulties in their study journey.
