Entry Requirements

When you study with TAFE NSW, we want you to succeed. Entry requirements allow us to make sure that you have the right pre-existing knowledge and skills to achieve your chosen qualification. You will need to provide evidence that you meet the requirements listed in this section.

ENTRY REQUIREMENTS

TAFE NSW offers the Certificate III in Individual Support (Ageing) as either a traineeship or non-traineeship, so you can shape the career you want.

Non-traineeship

There are no entry requirements for non-trainees. You can enrol in this course now.

Traineeship

To be eligible for this course you must:

- Be employed in the aged care industry as this course is delivered in the workplace
- Have a signed traineeship contract

COURSE SUCCESS REQUIREMENTS

During your study, you will need to meet specific requirements that are necessary for you to complete your course work and be successful.

You will need to meet the following success requirements to be able to undertake work placement within industry. Your teacher will let you know when you need to provide evidence of:

- Australian National Police Record Check
- Occupational assessment, screening and vaccination against infectious diseases
- Health care worker/student vaccination record card
- Working with Children Check (WWCC) depending on your work placement
- Signed code of conduct form and any other forms
- Any additional evidence your work placement provider requires

WORK PLACEMENT

Work placement provides you with opportunities to practise responding to situations and circumstances that cannot be replicated in a learning or simulated environment. Work placement strengthens your training and supports continued learning and assessment in the workplace.

During your course you will undertake a mandatory 120 hours of work placement with a suitable industry employer.

Depending on your mode of study, TAFE NSW will either arrange your work placement for you or support you to find one.

IS THIS COURSE RIGHT FOR YOU?

To be prepared for this course, it is recommended that you:

- Enjoy working with people
- Have good communication skills
- Have the ability to multi-task
- Are a collaborative team player

You must also have a reasonable level of fitness and flexibility to carry out:

- Manual handling tasks
- First aid responses including performing CPR while kneeling on the floor

ADDITIONAL REQUIREMENTS

With 130 locations across the state, TAFE NSW tailors qualifications to meet the needs of the local community and specific student groups (like apprentices, fast-tracked and online students). To make sure this course is the right fit for you, we will need you to demonstrate that you can meet the additional requirements below.

COURSE ENTRY REQUIREMENTS

Students should be over the age of 16, as recommended by our aged care industry partners.

A learner needs a competent level of reading and writing skills (ACSF Level 3) and a level of skills that will enable them to safely care for people in a busy environment.

Learners must have a Criminal Record Check that will allow them to complete work placement with local industry partners & have physical ability to safely care for others.

Students are expected to be able to work independently and may have some foundation knowledge and skills in the health and informal caring areas. This can include any previous or ongoing experience that will have contributed to their awareness of and development in the community services industry.

Teachers will organise student work placement (120hrs) and match students to relevant facilities with which TAFE NSW has a student placement agreement. You will be responsible for travel costs to complete on the job learning activities (workshops held at Wagga, Albury, Young, Finley and Griffith only) and for having the appropriate clothing for work placement (white polo shirt, black/navy pants and black/navy enclosed shoes with non-slip soles).

INFORMATION SESSIONS

There are no information sessions currently scheduled for this course.

STUDY COMMITMENT

This is a part-time blended course. You will need to attend approximately 4 hours of weekly Video Conference and monthly face-to-face workshops for 36 weeks. As well as the in-class component, you will need to complete approximately 8 hours of other study per week.

You may also be required to complete approximately 8 hours of additional study each week outside of class hours, including assignment preparation, homework and research.

This course is offered by Connected Classroom. This is just like a regular classroom, but teachers and students use the latest video conferencing technologies.

The CONNECTED CLASSROOM method of delivery involves a weekly interactive class via live "Video Conference", with all the weekly coursework completed online. This allows a level of flexibility for students to approach their work independently, and on their own schedule. With a Connected Classroom, your teacher will be in one TAFE location and you can join the class from your home (using your own computer with camera and internet) or another TAFE location (using TAFE resources). You will be able to see and talk to your teacher and other students as though they were in the room with you. The mandatory practical workshops bring the theory to life each month at selected campuses who have practical teaching labs, offering qualified educators to teach and assess all the practical skills required to prepare you for work placements and a career in the aged care industry.

IS THIS COURSE RIGHT FOR YOU?

This course offering is designed for people who are interested in caring for older people in an aged care facility.

SMART AND SKILLED FEES

This course is government-subsidised, meaning you pay a portion of the full course fee to TAFE NSW and the NSW Government will pay the balance. However, you must meet certain eligibility criteria for this to apply.

Depending on your previous qualifications and experience, your fee may be less than the maximum fee quoted. Your actual fee and eligibility for concession/exemption will be calculated and confirmed during the enrolment process.
