Course Description

Some job roles may require tasks to be performed with a moderate level of autonomy and/or the provision of supervision/leadership to other staff/volunteers.

No licensing, legislative or certification requirements apply to this qualification at the time of publication.

ENROLLING IN FIRST AID UNITS OF COMPETENCY

If you are seeking to enrol in a First Aid unit of competency you are advised that to complete the unit you must be able to perform basic life support skills, for example control bleeding and perform cardiopulmonary resuscitation (CPR). If you have a disability that would prevent you from performing required basic life support skills you are advised that you will not be able to achieve the unit of competency.

Fee Details

Payment by instalment may also be available. Your fee and eligibility for concession/exemption will be calculated and confirmed during the enrolment process.

WORK PLACEMENTS

2. STUDENT READINESS FOR WORK PLACEMENT

Generally work placements will only occur after there has been a reasonable amount of student/teacher contact and when the teacher is satisfied that you are ready to benefit from workplace learning and perform workplace duties. Your teacher can provide further information.

3. NSW HEALTH

Before you commence any clinical placements in NSW Health facilities, you will be required to

- Meet NSW Health's - Criminal Record Check requirements;
- Sign the NSW Health Code of Conduct form and any other forms, as required by NSW Health;
- Undertake Occupational Assessment, Screening and Vaccination against Infectious Diseases and provide your Health Care Worker/Student Vaccination Record Card.

When you enter the campus via Gate 2, D Block is on your right.

In order to be successful in this course, you need to have a genuine interest in working with children and supporting their growth and development. You need to be able to work with people of all ages and backgrounds. There are inherent foundation skills that require literacy and numeracy skills. There is a minimum requirement of 100 hours of work placement in a school setting as a mandatory part of this course. Workplace attendance days are flexible in order to meet the needs of students, and are communicated professionally with the school contact person. Students must complete these work placement days (approximately 20 days) during the 18 week duration of the course. Children's Education and Care teachers assist in the organisation of student work placements.

You are required to hold a current Working with Children Check prior to going on work placement. To apply for a Working with Children Check complete the application at www.kidsguardian.nsw.gov.au. If you are in paid work in a child related industry will need to pay a fee of \$80, Volunteers pay \$0.

A Unique Student Identifier is required prior to enrolment. To apply for your USI visit www.usi.gov.au. If you cannot remember your USI or if you have forgotten you have one, please visit the USI Website for assistance in retrieving your USI.

Attendance

Students attend class on their nominated class day (one day per week), from 9.30am to 2.00pm. It is also expected that students will complete approximately 20 hours per week of private study, assignment preparation and research.
