Course Description

This qualification reflects the role of support workers who complete specialised tasks and functions in aged services; either in residential, home or community based environments. Workers will take responsibility for their own outputs within defined organisation guidelines and maintain quality service delivery through the development, facilitation and review of individualised service planning and delivery. Workers may be required to demonstrate leadership and have limited responsibility for the organisation and the quantity and quality of outputs of others within limited parameters.

To achieve this qualification, the candidate must have completed at least 120 hours of work as detailed in the Assessment Requirements of the units of competency.

No licensing, legislative, regulatory or certification requirements apply to this qualification at the time of publication.

ENROLLING IN FIRST AID UNITS OF COMPETENCY If you are seeking to enrol in a First Aid unit of competency you are advised that to complete the unit you must be able to perform basic life support skills, for example control bleeding and perform cardiopulmonary resuscitation (CPR). If you have a disability that would prevent you from performing required basic life support skills you are advised that you will not be able to achieve the unit of competency.

WORK PLACEMENTS

1. NSW HEALTH

Before you commence any clinical placements in NSW Health facilities, you will be required to Meet NSW Healths - Criminal Record Check requirements; Sign the NSW Health Code of Conduct form and any other forms, as required by NSW Health; Undertake Occupational Assessment, Screening and Vaccination against Infectious Diseases and provide your Health Care Worker/Student Vaccination Record Card. You will also be required to undertake a number of unsupervised learning activities estimated at 10 hours per week.

There are a number of units that you are required to complete in the work place. There will be 120 hours of mandatory work placement where you will be required to attend morning shifts Unstructured learning for the course duration is approximately 10 hours per week and includes revision, library research, self study and reading.

INFORMATION SESSION

There are no Information Sessions scheduled at this time. Please contact campus for more information Participants in this programme are a mixture of learners who may or may not have previous experience or qualifications They are from diverse backgrounds and have met the entry requirements through a literacy and numeracy test. The learner body as a whole will represent a wide variety of age groups and ethnicities generally. Most learners have a moderate level of literacy and can work independently with little supervision. Allowance is made for the needs of particular groups (e.g. people with disabilities, and

people who may have literacy or numeracy difficulties, such as speakers of languages other than English. They may be referred to Foundation Studies if they are requiring extra assistance with their literacy or numeracy. The course is aimed at those who wish to work or those who are currently working in the community and/or residential setting and seeking a qualification. Many of the learners are CALD and are International students. Learners present from a variety of different backgrounds and ages. Each student will be required to complete 120 hours of practical experience in a qualified Aged Care facility.
