INDUSTRY DEMAND

The demand for personal care workers is growing.

Aged and disabled care jobs are projected to increase by 69,200 places, while nursing support and personal care worker jobs are projected to increase by over 11,400 over the five years to 2023.

It is expected that this sector will be launched into rapid change and growth based on the findings and recommendations of the recent Royal Commission into Aged Care.

Entry Requirements

When you study with TAFE NSW, we want you to succeed. Entry requirements allow us to make sure that you have the right pre-existing knowledge and skills to achieve your chosen qualification. You will need to provide evidence that you meet the requirements listed in this section.

ENTRY REQUIREMENTS

TAFE NSW offers the Certificate IV in Ageing Support as either a traineeship or non-traineeship, so you can create the career you want.

Non-traineeship

There are no entry requirements for non-trainees. You can enrol in this course now.

Traineeship

To be eligible for this course you must:

- Be employed in the aged care industry as this course is delivered in the workplace
- Have a signed traineeship contract

COURSE SUCCESS REQUIREMENTS

During your study, you will need to meet specific requirements that are necessary for you to complete your course work and be successful.

You will need to meet the following success requirements to be able to undertake work placement within industry. Your teacher will let you know when you need to provide evidence of:

- Australian National Police Record Check
- Working with Children Check (WWCC) depending on your work placement
- Any additional evidence your work placement provider requires

WORK PLACEMENT

Work placement provides you with opportunities to practice responding to situations and circumstances that cannot be replicated in a learning or simulated environment.

During your course you will attend a one-day workplace orientation, and complete one of the following levels of mandatory work placement hours:

- 120 hours (15 days) of work placement - if you are already working in the industry
- 240 hours (30 days) of work placement - if you are new to the industry

Depending on your mode of study, TAFE NSW will either arrange your work placement for you or support you to find one.

IS THIS COURSE RIGHT FOR YOU?

To be prepared for this course, it is recommended that you:

- Enjoy working with people
- Are able to work independently
- Are empathetic and patient
- Have good organisation and time management skills

You must also have a reasonable level of fitness and flexibility to carry out:

- Manual handling tasks
- First aid responses including performing CPR while kneeling on the floor

STUDY COMMITMENT

This is a part time day course. You will need to participate in approximately 2-3 hours of online study per week and attend 6 workshops every second month for 42 weeks.

As well as the in-class component, you will need to complete approximately 8.7 hours of other study per week.

You may also be required to complete approximately 4.1 hours of additional study each week outside of class hours, including individual study, revision, reading and Library/learning hub.

SMART AND SKILLED FEES

This course is government-subsidised, meaning you pay a portion of the full course fee to TAFE NSW and the NSW Government will pay the balance. However, you must meet certain eligibility criteria for this to apply.

Depending on your previous qualifications and experience, your fee may be less than the maximum fee quoted. Your actual fee and eligibility for concession/exemption will be calculated and confirmed during the enrolment process. Payment plans are available through TAFE NSW for Smart and Skilled eligible qualifications.

To be enrolled in this course, you need to be able to provide evidence that you are:

- currently employed as an aged care worker in the aged care sector
- have a sound level of literacy, English language skills and entry level employability and life skills which will enable you to provide support to clients in your work role upon course completion.
- have basic computer skills as course work and assessments will be accessed through an online learning platform.

To successfully complete this course, you will need:

- to have the cooperation of your Aged Care employer to allow you to complete 120 hours of onsite work placement with a Certificate IV worker, to learn this role. Assessment will be completed by a TAFE teacher/assessor.
